## Travel vouchers must be reviewed

A travel voucher review program is currently in effect in the Air Force Reserve. All travelers will ensure that their travel voucher is reviewed by someone within their chain of command who is authorized to perform the review.

There was a list of reviewers published in June. If you are in doubt as to who is authorized to review your voucher, check with your OIC or NCOIC.

This program has been instituted to assist the Air Force Reserve in its efforts to stop the effects that fraud, waste and abuse are having on its financial resources. Despite previous efforts along these lines, incidents involving personnel spanning all grades and positions continue to surface.

# SURE-PAY a sure bet

Eight out of ten Air Force members now belong to SURE-PAY, the Air Force's direct pay deposit program which automatically puts a member's paycheck into his or her bank account. SURE-PAY eliminates the chances of not getting your pay because of theft, loss in the mail, or even a postal strike.

Have you ever made plans with your next paycheck to buy that item you'd been waiting weeks to get, and then not received your check in the mail? That won't happen with SURE-PAY.

The reviewers will indicate their concurrence with the travel voucher by placing their signature in the upper left hand margin of the voucher. The traveler will have the opportunity to justify any items in question.

If the reviewer concurs with the explanation, the voucher will be signed indicating concurrence and sent on its way.

Where a disagreement exists between the traveler and reviewer, the reviewer will attach a short, handwritten note to the voucher before submitting it for payment.

Should the note and voucher get separated, the lack of a signature should trigger a question of suspicion on the part of the paying office.



Those long check cashing lines at the bank or store could be a thing of the past. If you occupy a mobility position, participation in SURE-PAY is strongly suggested. Then if you're out of town, your family won't be financially burdened because they could not cash your paycheck.

With all this going for it, SURE-PAY is a sure bet for any Air Force member. For more information on the advantages of SURE-PAY, stop by room 216 in building 1043. While you're there pick up a SF Form 1199A, fill it out, and give it to your bank. The sure way is with SURE-PAY.

# Deserving Airman Commissioning Program —

The Deserving Airman Commissioning Program selection board probably will not meet until August 1984, but prospective applicants should begin preparation now. Suspenses imposed by higher headquarters require the 507th TFG to process all completed applications not later than April 1984 UTA. Personnel who qualify, in accordance with AFR 36-15, and wish to apply should get a checklist from DPMQ (Bldg 1043, Room 240) and begin working on their applications now. Some requirements are very time-consumming, i.e. completion of ECI Course 7D, and the Air Force Officers Qualification Test (AFOQT). The AFOQT will be administered during a UTA in the near future by appointment only. For testing call Ms Knight or TSgt Carlson at ext. 7491.

# Restraining tragedies

More than 37,000 drivers and passengers are killed in auto accidents each year in the U.S. An additional 2 million people receive disabling injuries, costing more than 435 million dollars annually. Studies show that using seat belts would reduce these fatalities and serious injuries by 35 to 60 percent.

Just as important as buckling up is the responsibility of adults to make sure that children of all ages are buckeled up. Child safety seats should be used beginning when the infant rides home from the hospital. Auto accidents are the number one killer and crippler of children.

The 8-week-old daughter of a Vance AFB, OK, airman was killed in a traffic accident July 30 after she was thrown from her father's car. Her parents escaped the incident with only minor injuries.

Fall signals the start of the home heating season for much of the nation. Check your equipment before the heating season gets too far along.



Check furnaces, fireplaces, stoves and portable heaters. Service as necessary to avoid fire risk, excessive energy consumption and breakdown. Check flues and chimneys. If you burn wood, your chimney may need cleaning more often to remove creosote build up.

Don't use excessive amounts of paper to build roaring fires in fireplaces. It is possible to ignite soot in the chimney by over building a fire.

Never burn charcoal in a fireplace. Burning charcoal gives off a deadly amount of carbon monoxide. It is equally dangerous to burn charcoal in a charcoal broiler or hibachi unit inside the house.

If you burn pallet or crate lumber to save on buying cord wood, beware. Much of this type lumber is treated with preservatives and may cause respiratory problems for you and your family.

Provide adequate ventilation when using kerosene, oil or LP gas heaters. Set portable heaters away from combustibles and where they won't be bumped or tipped.
