Reservists suggest changes

A Department of Defense-wide identification card for reservists' dependents and the use of morale, welfare and recreation equipment on or off base were among suggestions reviewed by Air Reserve Forces policy boards re-

The Air Reserve Personnel Center/ Air Force Reserve Policy and Advisory Council convened here to look at 16 recommendations for improving the Reserve. The Air National Guard/ AFRES Enlisted Advisory Panel gathered at the ANG Support Center, Andrews AFB, Md., to evaluate 20 ideas affecting the Reserve and Guard.

Seven items were approved by the advisory council. Items affecting AFRES members were recommendations to investigate the inequities and inconsistencies in the payment of per diem between officers and enlisted members and to make educational benefits available to officers regardless of their degree objective.

The enlisted panel endorsed six ideas. Those items included sugges-

• Have the Air Force consider

adopting a ribbon similar to the Army reserve components' overseas training

· Allow a deduction for U.S. Savings Bonds from reservists' monthly

 Establish leave procedures for use by the active service and the American Red Cross for emergency situations affecting reservists.

Items approved by the advisory council were sent to Maj. Gen. Roger P. Scheer, chief of Air Force Reserve. Recommendations endorsed by the enlisted panel went to General Scheer and Maj. Gen. John B. Conaway, director of the Air National Guard. The generals review the items and refer them to the Air Reserve Forces Policy Committee and other agencies within the Air Staff.

Reservists may present recommendations to the council or the panel on plain bond paper or ARPC Form 2, "Policy and Advisory Council or Advisory Panel Recommendation," and send them to HQ ARPC/XPXC, Denver, CO 80280-5000. (AFRNS)

Self-employed reservists can obtain forms from their Air Force Reserve pay office and should return the completed forms to that office, said Mr. Markle. If reservists don't turn in the new form to their pay office by Oct. 17, tax allowances may automatically be adjusted to one deduction for single and two deductions for married members.

People who've already given a form to their employer don't have to do it again unless they want to make a

Reservists who've filed either form and received at least one paycheck showing their new tax withholding may want to obtain IRS Publication 919,

"Is My Withholding Correct?" calling toll free 1-800-424-3676.

Another change to the tax law affects claiming dependents in 1987. Social security numbers must be listed for all dependents claimed who're age 5 or older. Previously, the age requirement was 10 or older.

To obtain a social security number, apply at the nearest social security office by filing Form SS-5, Application for a Social Security Number Card. A birth certificate or other birth record and proof of identity must be presented for each new applicant. For those born outside the United States, proof of citizenship or lawful alien status is also required. (AFRNS)

Gives commanders flexibility

Man-day system changes

Air Force Reserve members may benefit from changes in how their units handle reserve personnel man-days and related travel in the coming fiscal year, according to AFRES comptroller offi-

Starting Oct. 1, AFRES unit commanders became involved in new programs to further decentralize management of the Reserve Personnel Appropriation, said Pete Jones, chief of AFRES budget operations. Some of these changes will come about through a program called the Personnel Budgeting and Accounting System. PBAS will give commanders a checkbook approach to management of the reserve man-day program, Mr. Jones said.

Reserve man-days account for some 20 percent of the costs in this appropriation. According to Stu Markle, 507th budget officer, "Unit commanders will have maximum authority to redistribute resources - man-day dollars rather than man-day tours - to match continually changing mission needs regardless of the type of man-day required. This will give commanders added authority to go with the responsibility

and accountability they already have."

"With a more direct say in how reserve man-day dollars will be used, unit commanders, managers and reservists will be able to forecast and schedule school and special tour training with greater confidence. This means improved training opportunities for reservists and the Air Force Reserve," Mr. Markle added.

A key policy change will affect man-day support between units. Starting in October, a reservist's unit of assignment will pay the cost of mission-driven man-days in support of another unit or activity.

Another new program, Travel Budgeting and Accounting System, will give commanders better control of unit travel funds.

"With the current travel system, commanders don't always know how much travel money they have because it takes about six months for the average reserve travel voucher to flow through the accounting system after it's been paid," Mr. Jones said. "That time will be reduced to within a month at the most under the new system."

The exercise will take place at the Headquarters Military Airlift Command Ground Combat Training Center known as "VOLANT SCORPION."

Tinker's security police, specially trained in air base ground defense, have been preparing for the event for the past several weeks. The police squadron's opponents during the exercise will be tough to deal with, Captain Currie said.


