## Airmen must revalidate dependents by Dec. 31

WASHINGTON (AFNS) -- By December 31, every Airman will be required to provide their servicing finance office with documentation for all dependents as part of Air Force audit readiness efforts.

This one-time, Air Force-wide recertification process will allow the Air Force to validate Airmen's basic allowance for housing entitlements, ensuring every dollar of the \$5.4 billion the Air Force spends annually on BAH is fully auditable.

"When we say the Air Force is not audit compliant, that doesn't mean that money is missing or being misspent," said Doug Bennett, the deputy assistant secretary of the Air Force for financial operations. "Generally, it means that we lack the required documentation for our spending to be considered auditable. In the case of BAH, we need Airmen's marriage certificates, birth certificates for children and divorce decrees that require child support properly documented by our finance offices to ensure we can audit \$5.4 billion in Air Force spending."

Beginning this month and continuing through December, Air Force finance offices will contact Airmen across the total force by email to notify them of their responsibility to provide dependent documentation. Their finance office will tell them exactly which documents are required. Additionally, Airmen who recently provided documentation may not be required to do so again. Airmen should wait to be notified by their finance offices rather than bringing in documentation unsolicited, Bennett said. Waiting to receive notification will eliminate unnecessary duplication of effort for some Airmen.

Once notified, Airmen will have 30 days to provide the required documents to their servicing finance office or have their housing allowance status reduced to single-rate. Deployed Airmen and those on extended leave or temporary duty will be given special consideration in meeting the 30-day deadline.

# **Air Force leaders lay out budget priorities**

Reserve chief: 'There are no easy choices left'

WASHINGTON -- Senior Air Force leaders testified April 2 on Capitol Hill about funding priorities and fleet reductions announced in early March as part of the FY15 Air Force budget request.

Sen. Dick Durbin (D-Ill.) and Sen. Thad Cochran (R-Miss.) led the hearing at the Senate Appropriations Subcommittee on Defense. They questioned Air Force and Reserve Component leaders about modernization strategies, divestment, and unit relocation plans in light of the \$109.3 billion FY15 Air Force budget request.

Secretary of the Air Force Deborah Lee James began the testimony, praising the "superb total force teamwork" she has seen in her first months on the job. She cited the "challenging times" of today's fiscal environment, and stressed that there will be "more reliance on the Guard and Reserve as we go forward."

The FY15 Air Force budget request, which meets funding levels laid out in the Bipartisan Budget Act, would cut the A-10 Thunderbolt II and U-2 fleets in order to continue the Air Force's top recapitalization priorities: the KC-46A Pegasus, F-35A Lightning II and the Air Forces, wings, groups and squadrons would, in my Long Range Strike Bomber.

Air Force Chief of Staff General Mark A. Welsh III in an unsustainable Air Force Reserve." addressed concerns about the A-10 divestment, stating that in the bigger picture, it made sense for other multirole fighters to absorb the close air support mission.

"It's about balance," he said. "There are no easy choices left."

Lt. Gen. James F. Jackson, Chief of Air Force Reserve, Traditional Reservists." took questions about the movement of 10 C-130J aircraft from Keesler AFB, Miss. to Little Rock AFB, Ark. He explained that moving the Reserve's C-130J squad-

ron to Little Rock, with the two active duty squadrons and schoolhouse, would allow the Reserve to maintain its current capability while decreasing costs.

James also praised the National Commission on the Structure of the Air Force for its recommendations, citing only "a couple of areas of disagreement."

In his written statement, Jackson also praised the report but addressed concerns about two recommendations to disestablish Air Force Reserve Command and eliminate its organizational structure.

He stated, "The notion of disestablishing Air Force Reserve Command and inactivating the Numbered opinion, undo six decades of lessons learned and result

He stressed the importance of professional force development in growing leaders for the Air Force, adding that the commission's recommendation "would eliminate leadership pathways to develop our Citizen Airmen, especially for our Air Reserve Technicians and

He touted the Reserve's retention rate--close to 90 percent over the past seven years--and highlighted the Reserve's unique ability to attract "Airmen for Life."

# **Staying safe in hazardous weather**

Know the difference between a tornado watch and warning and the necessary actions for each

**SAFETY** 

What is the difference between a tornado watch and a tornado warning?

A tornado watch is issued by NOAA Storm Prediction Center meteorologists who watch the weather constantly across the entire U.S. for weather conditions that are favorable for tornadoes. A watch can cover parts of a state or several states. Watch and prepare for severe weather and stay tuned to local radio or TV news broadcasts to know when warnings are issued.

A tornado warning is issued by your local NOAA National Weather Service Forecast Office meteorologists who watch the weather 24/7 over a designated area. This means a tornado has been reported by spotters or indicated by radar and there is a serious threat to life and property to those in the path of the tornado. Act immediately to find safe shelter. A warning can cover parts of counties or several counties in the path of danger.

#### *How is tornado strength rated?*

The most common and practical way to determine the strength of a tornado is to look at the damage it caused. From the damage, we can estimate the wind speeds. An "Enhanced Fujita Scale" was implemented by the National Weather Service in 2007 to rate tornadoes in a more consistent and accurate manner. The EF-Scale takes into account more variables than the original Fujita Scale (F-Scale) when assigning a wind speed rating.

#### What precautions should you take when a tornado watch is issued?

When a tornado watch is in effect, you can take certain precautions to lessen danger. If possible, move cars inside a garage or carport to avoid damage from hail, which often accompanies severe storms. Keep your car keys and house keys with you.

Account for family members at home. Have your emergency kit ready, and keep your radio or TV tuned to weather reports.

#### What actions should you take when a tornado warning is issued?

At home: take cover in the basement under something sturdy. If there is no basement, a small room in the middle of the house is best, like a closet or bathroom. Always stay away from outside walls and windows.

At work or school: find a designated shelter area. Stay away from large open rooms like auditoriums and gymnasiums.

In a car: leave the vehicle. Seek a safe structure or lie down in a low area with your hands covering the back of your head and neck. Keep alert for flash floods that often accompany severe storms.
