# FORMER ENLISTED MAN RETURNS AS 937TH PERSONNEL OFFICER

Capt Larry G. Bunch is the new Personnel taff Officer for the 937th replacing Maj Job Williams. Bunch's effective reporting date was Sept. 24 and he attended his first UTA in the new position in October.

Immediately prior to coming to the unit, Bunch was personnel Officer with the 939 MAG at McChord AFB, Calif. He had been Military Personnel and Administrative Services officer for the 939 Tactical Airlift Group, Portland IAP, Ore., before moving to McChord.

# LEGAL NOTES PRECAUTIONS ON POWER OF ATTORNEY

A power of attorney is a legal document in which a person either grants another individual the legal authority to act as his agent, either for some particular purpose or for the transaction of business in general.

It should be remembered that the agent who holds such power has, within the limits granted by it, full authority to deal with an owner's property without consulting him.

Thus, execution of a power of attorney should be taken only after consultation with legal counsel.

A general power of attorney is seldom necessary. It is usually more advisable to execute a limited or a special power of attorney with authority to perform certain acts and no more.

Legal authority granted in a power of attorney is revoked by the death of either owner
or agent; by any time limit set by the document itself; or by specific revocation. However, a written revocation is not always
effective because all persons who rely on the
original power of attorney must have notice
of the revocation.

It is best to have a time limit specified in the power of attorney itself. A new power of attorney can always be made when the old one expires.

# COLONEL EVAN F. BOURNE JR. ELEVATED TO CHIEF OF STAFF

Col. Evan F. Bourne Jr., has been elevated to the post of chief of staff of the Fourth Air Force Reserve Region headquartered at Randolph AFB, Tex.

Colonel Bourne had been serving as deputy chief of staff for Personnel.

A veteran of 27 years service, the colonel has been service in England, Hawaii, Germany and Turkey. He was graduated from Miami (Fla.) High School, earned his bachelor's degree at the University of Miami, and received his master's degree from the University of Chicago.

BASIC U.S. COMMITMENT

Among non-C mmunist Asians in itions of responsibility, the comment of the United States to help free Asians resist Communist expansion is widely approved. Support of the U.S. and South Vietnam, but by leaders of most neutral countries in the area as well. For Example:

Prince Souvanna Phouma, Prime Minister of Laos, in an interview published in U.S. News and World Report, Nov. 6,

1967:

Q. "Some critics of the war say the United States should pull out of South Vietnam. As the Premier of Laos, which has borders with both South and North Vietnam, what do you think would be the effect of such a withdrawal?"

A. "There would be a danger for the countries of East Asia--a very great danger. Right now, SOuth Vietnam alone cannot face the danger of the North. Thus, if the Americans and allies leave tomorrow, South Vietnam would be Communist.

Should South Vietnam become Communist hat is to say, should all of Vietnam scome Communist --- it would be difficult for Laos to exist. The same goes for Cambodia, the same for other countries. "I have always said that if all of Vietnam becomes Communist, we could do nothing but pack our bags and leave."

### CIVIL WAR OR AGGRESSION

Another point on which ther is wide agrement in Asia is the nature of the war in Vietnam.

Philippine president Ferdinand E.
Marcos, Manila, 1966: "It is established
beyond dispute that the war in Vietnam is
not a civil war. It is a war on an international scale involving massive aggression
from Communist North Vietnam with the
active encouragement of Communist China."

Korean President Chung Hee Park, Korea, 1966: :The forces which support and control the Viet Cong in Free Vietnam today are the same forces which 16 years ago supported and controlled the southward

aggression of the Communist troops in Korea... The situation in Vietnam is more than a simple domestic problem of that

country. It represents rather a confrontation of the free world with Communist tyranny."

As long ago as 1962 the International Control Commission reported that "there is sufficient evidence to show beyond reasonable doubt" that the North Vietnamese Army was conducting hostile operations against South Vietnam in clear violation of Geneva accords.

Since that time, Asian leaders have charged that North Vietnamese forces have also conducted offensive operations against neutral Laos and are training and equipping guerillas in Thailand. (DoD VR-9)
